


Loss or damage to insured business items — whether on or off premises — from a wide range of unforeseen events, beyond standard policy exclusions.



Electronic Equipment

Loss or damage related to construction, plant, or machinery, including risks like equipment breakdown, contract works incidents





Accidental physical loss or damage to insured electronic devices — such as computers, servers, and medical or office equipment

Financial loss suffered by a business due to dishonest or fraudulent acts committed by an employee.



Fire & Special Perils

Loss or damage to insured property resulting directly from theft or attempted theft, including burglary or robbery.



Loss

Loss or damage to insured property caused by special risks such as riots, strikes, civil commotion, and terrorism etc. Loss or damage to goods while being transported from one location to another.



Loss or damage to insured property caused by fire, lightning, explosion, and other specified risks such as storm, flood etc.

Theft

Financial losses arising from damage to crops, plants, or insured animals due to risks such as natural disasters, disease, theft, or accidents specified in the policy.
